

## “Animal Planet Goes Wild!” SWEEPSTAKES

### OFFICIAL RULES

Please read the Official Rules and Regulations (“Official Rules”) of the “Animal Planet Goes Wild! Sweepstakes” (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes. By entering the Sweepstakes, you agree to these Rules.

1. **Dates:** This Sweepstakes is valid from 2/1/2019, 12:00 AM MT, through 2/28/2019, 11:59 PM MT (“Sweepstakes Period”).
2. **How To Enter:** To enter, submit an entry through the Dish website ([www.Mydish.com/perks/sweepstakes](http://www.Mydish.com/perks/sweepstakes)) and follow the “How to Enter” instructions (“Entry”). Normal Internet access and usage charges imposed by your online service will apply. It is your sole responsibility to notify the Administrator if you change your email address (“Address”). One entry, per person, per day.

Any sort of automated Entry sent via bot is strictly prohibited. Any entrant suspected or found to be submitting automated Entries of any kind will be disqualified.

3. **Eligibility:** This Sweepstakes is open to legal residents of eligible forty-eight (48) contiguous United States and D.C. (excluding, without limitation, residents of New York, Florida, Puerto Rico and other U.S. territories) who are 18 years of age (or age of majority in his or her state) or older at the time of entry **and existing DISH customers as of 1/31/2019**. Void in Alaska, Hawaii, New York, Florida and where prohibited. Employees, directors, officers and their immediate families (spouse, parents, children, siblings, and each of their spouses regardless where they live) or members of households of DISH Network L.L.C., (“DISH”), Discovery Communications, LLC (“Discovery”) and each of its respective parent companies, subsidiaries, advertising, design, print production and publicity agencies and anyone connected with the production and distribution of this sweepstakes (collectively the “Sweepstakes Entities”), are not eligible to enter or be awarded a prize.

If potential Prize Winner does not reply within allocated time, does not accept prize, or is found to be ineligible or not in compliance with these Official Rules such prize will be forfeited and may be awarded to an alternate Prize Winner, time permitting. Odds of winning will depend upon the total number of eligible Entries received.
7. **Prize and Approximate Retail Value (“ARV”):** One (1) Grand Prize (the “Grand Prize”): round trip coach class airfare for Prize Winner and three (3) guests to New York, NY. Trip includes:

8. **Travel:** Travel related to the Grand Prize must be round trip. Sponsor will determine airline, flight itinerary and hotel location and accommodations in its sole discretion. No refund or compensation will be made in the event of

the cancellation or delay of any flight. Travel and accommodations are subject to availability. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by the Sponsor's airline carrier(s) of choice as detailed in the passenger ticket contract. Prize Winner will not receive difference between actual retail value and ARV. Grand Prize is non-transferable, and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the Grand Prize (or a component thereof) for one of equal or greater value if the designated prize should become unavailable for any reason. All travel must be completed by February 28, 2020 and must be arranged with Sponsor a minimum of thirty (30) days in advance and is subject to availability and Sponsor's approval. If Prize Winner is unable to complete or book Grand Prize during such time period, Prize Winner forfeits the Grand Prize in its entirety and an alternate winner may be selected. All travel dates will be approved by the Sponsor, and once made may not be altered except by Sponsor. Some restrictions may apply. Meals not described above, incidentals, tips, telephone calls, or any other personal expenses incurred during the trip are the responsibility of the Prize Winner. Prize Winner must sign and return an Affidavit of Eligibility and Publicity/Liability Release within seven (7) days of prize notification. Noncompliance within this time period will result in disqualification and an alternate maybe selected. Any person attempting to damage any website, defraud or in any way tamper with the Sweepstakes will be ineligible for any prize and may be prosecuted to the full extent of the law. The Sponsor or Administrator shall not be responsible for technical, pictorial, typographical or editorial errors or omissions in any marketing materials or these Official Rules. Entrant agrees that any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes or any prizes awarded and all issues and questions concerning the validity, interpretation and enforceability of these Official Rules shall be resolved individually, without resort to any form of class action, and exclusively in a court of competent jurisdiction sitting in Douglas County, Colorado.
