DISH "BBC AMERICA DOCTOR WHO" SWEEPSTAKES

OFFICIAL RULES

Please read the Official Rules and Regulations ("Official Rules") of the "DISH 'BBC America Doctor Who' Sweepstakes" ("Sweepstakes"). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes. By entering the Sweepstakes, you agree to these Rules.

- 1. **Dates:** This Sweepstakes begins on 9/18/15 at 12:00 AM Mountain Time ("MT") and ends on 11/03/15 at11:59 PM MT ("Sweepstakes Period").
- 2. Eligibility: This Sweepstakes is open to existing DISH customers as of the start date of the Sweepstakes who are legal residents of the forty-eight (48) contiguous United States and D.C. (excluding, without limitation, residents of the States of Alaska and Hawaii, Puerto Rico and other U.S. territories) and are 18 years of age (or age of majority in his or her state) and older at the time of entry. Existing DISH customers must be in good standing for the duration of the Sweepstakes Period. The Entrant who is selected as the grand prize winner (the "Grand Prize Winner") must have a unique, personal and valid social security number for Sponsor (defined below) to report the tax liability associated with acceptance of the grand prize (the "Grand Prize"). Valid social security numbers will be determined by Internal Revenue Service ("IRS") requirements as further defined in the "Prize Claims" section of these Official Rules. Upon clicking the "Submit" button, Entrants will receive one (1) Entry into the Sweepstakes. Normal Internet access and usage charges imposed by your online service will apply. It is your sole responsibility to notify the Sponsors if you change your email address ("Address").

"Entry" shall mean and refer to each Entry. Limit one (1) Entry per day per person, per household and per DISH account if applicable for the Sweepstakes Period. Any attempt by an Entrant to obtain more than the stated number of Entries by using multiple/different identities, email addresses, telephone numbers, account numbers and/or any other methods will void that Entrant's Entry and that Entrant may be disgualified from the Sweepstakes. Each Entrant must be the rightful owner (or have authorized use) of the Address associated with the Entrant's Entry. In the event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed submitted by the person in whose name the Address (provided via the Entry) is registered (the "Authorized Account Holder"). - 6. Winning/Notification: A random drawing will be held by Sponsors on or about 11/06/15. For the drawing, one (1) Grand Prize Winner will be selected from among all eligible Entries received during the Sweepstakes Period. Odds of being selected as the Grand Prize Winner will depend upon the total number of eligible Entries received during the Sweepstakes Period. Decisions of Sponsors are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects. Potential Grand Prize Winner will be notified by phone at Sponsors' discretion on or about 11/09/15. Sponsor will make two (2) attempts to reach the potential Grand Prize Winner by phone. Messages will not be left on voicemail or answering machines. Valid social security numbers will be determined by IRS requirements.
- Grand Prize and Approximate Retail Values ("ARV"): One (1) Grand Prize of a trip for Grand Prize Winner 8 and one guest to London, England will be awarded. Limitations of Liability: The Sponsors and Administrator are not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction nor unauthorized access to or alterations of Entry materials, or for technical, network, telephone equipment, electronic, computer hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive Entry materials by Sponsors or Administrator on account of technical problems or traffic congestion on the Internet or at the Website or any combination thereof. Any person attempting to damage the Website, defraud or in any way tamper with the Sweepstakes will be ineligible for any prize and may be prosecuted to the full extent of the law. The Sponsors or Administrator shall not be responsible for technical, pictorial, typographical or editorial errors or omissions in any marketing materials or these Official Rules. Entrant agrees that any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes

or any prizes awarded and all issues and questions concerning the validity, interpretation and enforceability of these Official Rules shall be resolved individually, without resort to any form of class action, and exclusively in a court of competent jurisdiction sitting in Monroe County, New York. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes and never shall include consequential, incidental or punitive damages, and in no event attorneys' fees.
